Provide the author of the work, the title of the posting in quotation marks, the web site name in italics, the publisher, and the posting date. Follow with the date of access. Include screen names as author names when author name is not known. If both names are known, place the author's name in brackets.

Title of the Container, Other contributors, Version, Number, Publisher, Publication date, Location. You only include the elements that are relevant to the type of source you're citing.

To indicate that you are citing a comment, follow the name with a period and then the words Comment on, followed by the title of the source (for example, the name of the article) in quotation marks. This is then followed by the title of the website in italics, and the publisher, if applicable.

MLA in-text citations are brief references that direct your reader to the full source entry. You include them every time you quote, block quote, paraphrase or summarize a source. The in-text citation must match the first word of the Works Cited entry – usually the author’s last name.
