Present these documents to the passport processor: (1) Dual Citizenship Documents (2) Old Philippine Passport or in case of loss, Affidavit of Loss (3) Completed Passport Application Form and (4) Birth Certificate from the National Statistics Office/Philippine Statistics Authority (5) Marriage Certificate from the National Statistics Office/ Philippine Statistics Authority for females wishing to use their married surname for the first time.

Travel Tax exemption is being granted to dual citizens departing the Philippines and returning to the US whose arrival is stamped on the Philippine passport and whose stay does not exceed one (1) year. For this purpose, a Travel Tax Exemption Certificate is issued upon presentation of both the Philippine and US passports.

How to Apply for Dual Citizenship in the Philippines 2018

Dual Citizen - Submit a PSA Birth Certificate or Report of Birth and Original Identification Document issued by the Philippine Foreign Service Post (FSP) or the Bureau of Immigration (BI). In addition, bring also government-issued IDs either from Philippines or from second country of citizenship. Provide also a photocopy of each document.

In case the name of the applicant in his/her PSA Birth Certificate is different from that in his/her foreign passport and other documents, the applicant shall execute an affidavit explaining such difference and present as supporting documents, two (2) public or private documents showing the correct name of the applicant.

Applicants who've availed of Dual Citizenship under RA 9225 Birth Certificate in Security Paper issued by the PSA or Certified True Copy of Birth Certificate issued by the LCR and duly authenticated by PSA. Transcribed Birth Certificate from the LCR is required when entries in PSA Birth Certificate are blurred or unreadable.
